Terms: Praise Unlimited's Band/Artist agrees to perform to the best of their ability to provide music consisting of gospel selections only, as originally agreed upon with no additional responsibilities. The Praise Unlimited Band/Artist agrees to furnish gospel music as noted above. This will begin on _____ and terminate on _____. The agreed upon compensation for the above services is \$_____. A deposit of half the agreed upon amount is immediately due to reserve your requested date. Deposits are not refundable. Cancellation after receiving signed agreement is allowable within 24 hours, but not on the day of the event full payment will be expected. In no event shall this agreement constitute an employment agreement, and Praise Unlimited's on-call gospel artist shall be considered as an independent contractor only and shall not be supervised by client, but shall accomplish original specifications presented by client with no additional responsibilities. Client agrees to be liable if artist must bring their own musical and audio equipment by providing insurance coverage in case of damage or theft to artist property. Praise Unlimited, Inc. retains all rights to the original music and materials of its artist and band, which they perform. All tapes, videos and materials that are the sole property of Praise Unlimited, Inc., if given or used, must be returned in the same condition given. In no event shall this agreement constitute an employment agreement, and Praise Unlimited, Inc., a sub-contractor with its band/artist as independent contractors and shall not be supervised by Client/Customer. Client/Customer must notify Praise Unlimited, Inc. in advance if it is required that Praise Unlimited's band/artist has to supply musical equipment. Client/Customer agrees to be liable for any damage to Praise Unlimited's/Artist's stage equipment resulting from a patron induced infraction or theft at client's place of venue. The artist will not supply or supplement musical instruments without the approval of Praise Unlimited, Inc. and client, which is an additional fee. Nevertheless, if the client's musical equipment is to be used in the performance of contracted services said artist, agent, or Praise Unlimited, Inc., shall not be held liable for poorly serviced, malfunctioning, defective equipment or bad or exposed wires, plugs, outlets, sound systems, as it pertains to this agreement and is hereby released from any and all future lawsuits or other legal action. Full payment before the commencement of the event, service or activity regardless of event causations, inclement weather, poor ticket sales, accidents or other acts of God. The signatures below are acknowledgement and receipt of the above listed terms this agreement supersedes all other agreements.

HOSPITALITY/AMENITIES: Where it is reasonable for engagements of one hour or more artist/band supplied by Praise Unlimited, Inc. should receive the following: (1) area of rest and preparation or private room (2) bottled water, fruit beverages, etc. (3) free meal for artists/band members only! Further amenities are subject to negotiations and are contained on additional riders.

PROMOTIONS OR EVENT: No marketing or promotional materials same being flyers, posters, press releases radio ads, TV ads, cable, website or tickets can be distributed involving Praise Unlimited, Inc., artist/bands without our approval and half of deposit payment. Additionally, verbal introductions by the master of ceremonies, printing of artist information sent by Praise Unlimited, Inc., in event programs and church bulletins are substantially important to us.

At NO time shall Steven Turner, On-Call Organist be subject to disciplinary actions such as suspensions with or without pay as he is NOT an employee but an independent contractor. If said actions are initiated, especially without prior knowledge or consent, an invoice will be send demanding FULL payment and be subject to enforcement.

I/We agree to abide by all requirements and obligations stated herein. This document serves as the sole agreement between Praise Unlimited, Inc. artists and bands, and:
